SCHOOL OF CRIMINOLOGY & CRIMINAL JUSTICE

The School of Criminology and Criminal Justice (CCJ) has undergone a tremendous amount of change, but the sentiment continues to be one of optimism; our program has a very bright future ahead of it. Several CCJ faculty are nationally and internationally recognized experts in their areas of study. The doctoral program is also internationally recognized and continues to be highly ranked by *U.S. News and World Report*.

Program Basics:

CCJ is a large, dynamic program with 17 tenure-track/tenured faculty, 2 emeritus faculty, 2 research faculty, 8 full-time and 4 part-time professional and support staff members as well as about 25 part-time faculty. The School offers educational programming on both the Omaha and Lincoln campuses and houses two research units: the Juvenile Justice Institute (JJI) and the Consortium for Crime and Justice Research (CCJR). The trend in majors, degrees awarded, and student credit hour production is upward.

Scholarly Productivity:

Over the last year, CCJ faculty have been actively engaged in traditional scholarly research as well as more applied, collaborative research efforts with local and federal agencies. Our faculty have authored or co-authored 41 peer-reviewed journal articles, 5 non-refereed articles, 3 scholarly books, 42 book chapters and encyclopedia entries, and 10 technical reports and non-refereed publications. They also currently have an additional 16 papers under review at scholarly journals and several others in progress. Faculty delivered 62 presentations at professional conferences in the last year, many of them invited presentations and many involving graduate student coauthors.

Future Directions:

- CCJ is continuing to expand its online offerings at both the undergraduate and graduate levels, and now has a fully online MS program. A full-time Distance Education Instructor was hired to support online initiatives within the School.
- CCJ is in the process of developing a graduate certificate "Managing Juvenile and Adult Populations" with Social Work.
- CCJ is exploring the development of a Corrections Leadership Initiative which will focus on professional development opportunities in corrections, probation, and parole.
- The Nebraska Center for Justice Research is moving through the approval process under the direction of Ryan Spohn. The Nebraska Legislature recently appropriated \$200,000 for the Center to study corrections reform and other issues related to crime and justice policy in Nebraska in 2014-16.

CENTER FOR PUBLIC AFFAIRS RESEARCH

The Center for Public Affairs Research (CPAR) celebrated its 50 Years of Service to the University, the Omaha area and throughout Nebraska. We designed an emblem, collected and displayed historical documents, developed a short history, including a 25 feet-long pictorial timeline representing the major events in CPAR's history, and held a celebration on November 8, 2014.

CPACS Diversity Initiatives:

CPAR was established in 1963 as the Center for Urban Studies. Its initial mission was to address urban problems and information needs. Over the years CPAR has gone through several name changes and numerous personnel changes that have modified its mission. During the past year, CPAR began to reexamine its historical urban mission within the current operating environment. Issues of diversity and social problems are key components in this effort. Activities include:

1. Strengthened relationships and developed collaborations with Black Studies and Office of Latino/Latin American Studies.

2. Worked with CPACS, other UNO faculty and staff and community organizations that have similar interests in the issues of diversity and social problems. (CPACS Urban Policy and Diversity Incubator, CPACS Diversity Committee)

3. Initiated the Nebraska Metro Poll (a large survey of 7,500 households) that is a complement to UNL's Rural Poll; to ensure adequate representation the Metro Poll included an oversampling of African-American and Latino households and Spanish letters and questionnaires. As a result of our efforts, for the first time, the Rural Poll oversampled Latino households and included Spanish letters and questionnaires in their general survey.

State Data Center Program:

- 1. As the lead agency for the Nebraska State Data Center, CPAR continued to manage the program that also consists of a network of 23 state and local agencies. 2014 is the 25th anniversary of CPAR's designation as the lead agency by the Governor.

CPAR staff provided technical assistance and advice on conducting surveys to CPACS and UNO faculty and students, nonprofit, and government agencies.

CPACS Support:

- Coordinated the Certificate in Fundraising Management program. In 2013-2014 there were 12 courses scheduled, with over 70 registrants, most taking multiple courses. Two participants received the Certificate in Fall 2013; and two are expected to receive the Certificate in Spring 2014. There have been over 150 individuals who have received the Certificate in Fundraising Management since CPACS/CPAR took over the program in Fall 2000.
- CPACS Websites Technical Support CPAR is providing technical support for 15 CPACS websites. CPAR also provides support for Office of Military and Veteran Services website. This past year approximately 25 duplicate or dormant websites were eliminated or consolidated in preparation for the conversion to the CMS.
