1.	All Activity Workers must successfully pass a sex offender registry search for Nebraska and the state(s) they reside.
2.	All Activity Workers driving activity vehicles must successfully pass a Driving Record Check.
3.	In the case of an emergency or accident involving your youth, parents/guardians will be notified, following notification of the appropriate emergency personnel.
4.	All UNO activities will comply with UNO's Youth Activity Safety Policy and Activity Worker Guidelines.
5.	As parent(s) or legal guardian(s) you give permission to this activity to use photos of your child in promotional media by checking this box and initialing :

The activity directors of University-sponsored activities, clinics and conferences reserve the right to immediately dismiss any youth from the activity, clinic or conference for disruptive or endangering behavior. Dismissed youth will be sent home at their expense and will be responsible for all other expenses associated with their dismissal. - (B) Guardian has hereby been made aware that Minor's participation in UNO Mav Kids Mega Craft Day has the following non-exhaustive list of particular risks: cardiovascular stress, sprains, strains, abrasions, dislocations, fractures, concussions, contusions, blisters, paralysis, death, and injury during travel to and from field trip sites, and the reckless conduct of other Recreational Activity participants.
- (C) Guardian, with the intention of binding oneself and Minor and their respective heirs, legal representatives, and assigns, assumes all risks, both known and unknown, even if arising from the negligence of the releases, in connection with participation in UNO Mav Kids Mega Craft Day and hereby releases all instructors, agents, operators and officials of the University of Nebraska at Omaha and the University of Nebraska Board of Regents from liability to the fullest extent permitted by law for any injury or damage which may befall Minor while participating in UNO Mav Kids Mega Craft Day, and agrees to save and hold harmless the University of Nebraska at Omaha, the University of Nebraska Board of Regents, and its heirs, legal representative, successors and assigns against loss from any further claims, demands or actions that may subsequently be brought by Minor or by any other person or persons arising out of the Minor's participation in UNO Mini Mav Kids.
- (D) In case of medical emergency, Guardian authorizes the University of Nebraska at Omaha or its representatives to take all reasonable steps to secure the health and safety of Minor, including, but not limited to first aid, ambulance transportation, x-ray examinations, anesthetic, medical or surgical diagnosis or treatment, and/or hospital care.
