Note: The American Community Survey is a sample of households and like all samples is subject to sampling and nonsampling error. The PUMS files are a subsample of completed records that contain the actual responses to the ACS questionnaire, and thus this subsample is subject to additional sampling error. The 2005 ACS was only conducted for persons living in housing units, and excluded the population living in Group Quarters (nursing homes, prisons, shelters, etc.). All data should be analyzed and used with caution.
