1. General Education transfer draft policy suggested language:

Students admitted to UNO with a Bachelors degree from a regionally accredited institution will have fulfilled UNO's general education requirements. Such students must still complete any general education requirements specified within their specific program of study, and any required prerequisites or other requirements stated in UNO's Undergraduate Catalog.

Students admitted to UNO with an Associate of Arts (AA) or Associate of Science (AS) degree from a regionally accredited institution will have fulfilled UNO's lower division general education requirements. Such students must still complete any upper division general education requirements, general education requirements specified within their specific program of study, and any required prerequisites or other requirements stated in UNO's Undergraduate Catalog.
