
# What is Six Sigma?



Six Sigma is a disciplined, data driven approach and methodology for eliminating defects by reducing variation and eliminating waste in any process.




### Variation vs Target (Original Specification)



LSL = Lower Specification Limit USL = Upper Specification Limit




### Variation vs Target (Customer Expectation)

"85% of the reasons for failure to meet customer requirements are related to deficiencies in systems and processes...rather than the employee. The role of management is to change the process rather than badgering individuals to do better."






Sigma Level


## Example Comparison of Exercise 1 & 2





#### **Defects and the Hidden Factory**


Each defect must be detected, repaired and placed back in the process. Each defect costs time and money.



Manufacturing Variation Causes A "Hidden Factory" Increased Cost - Lost Capacity



#### **Rolled Yield Versus First Time Yield**




Using Final Test First Time Yield ignores the hidden factory. Final test performance is a function of inspection/test or prevention.





#### **Design for Six Sigma Process Work Flow**










