The Office of Research and Creative Activity (ORCA) and the Office of Graduate Studies (OGS) announces the availability of funding for the Graduate Research and Creative Activity (GRACA) awards. GRACA grants support faculty-mentored UNO

graduate student research and creative activity. Grants of up to \$5,000 per student may be used to support student travel for data/information collection, project-related supplies and operational expenses, data collection and analysis, and/or a summer stipend.

- Eligibility is restricted to UNO graduate students who pay tuition and fees through UNO. Students must be enrolled during both spring and fall 2013 semesters (with no plans to graduate before December 2013). Students are required to identify a UNO faculty mentor who must approve the submission of the GRACA proposal. The faculty mentor must be a member of the graduate faculty.
- Deadline: January 24, 2013 (11:59 P.M. CST)

**Community/Agency graduate students will need to complete BOTH the CPCE exam (multiple choice questions) AND a written comprehensive exam (essay questions in core areas).** Please consult with your advisors, especially during the semester you anticipate graduating.

Students <u>NEED</u> to complete an application for practicum as early as you know your anticipated graduation date as spots are limited. In addition, you must apply AT LEAST one semester before you begin the practicum. <u>It is recommended that you</u> apply several semesters before you begin the practicum. Applications can be picked up in Roskens Hall 101. The application date determines priority of acceptance.

To students with concentrations in Clinical Mental Health counseling: As you apply for the Begin-

> ning Practicum COUN #8220 please remember the need to sequence this course with COUN #8250 and #8260 in a continuous fashion. As you begin this clinical sequence, you must take one course succeeding the next in each of the subsequent semesters. If you drop out during the 3 course sequence, we cannot guarantee your placement in future sections.

Please remember this is a continuous 3 course/3 semester sequence.

## **Group Experience Information**

All Counseling students must participate in a 20 hour group experience, as a client, prior to enrolling in COUN 8270 and COUN 8370. Students must also complete the 20 hour pre-group consent form which is available online <u>http://coe.unomaha.edu/</u> <u>couns/</u> under the Forms and Documents tab or from the counseling office, Roskens Hall 101. This form authorizes your group facilitator to consult with UNO Graduate Faculty regarding participation should it be necessary and advises your facilitator of the purpose of the experience. See Irene Harper, (402) 554-3648, for further information.

A 20 hour group experience is facilitated by the clinic coordinator several times each academic year. Contact Dr. Barnes, (402) 554-2306, or Andrea Joyce, (402) 554-4882, to sign-up. The cost is \$110. If signed up for participation, please make the check out to the UNO Counseling Clinic.

You also have the option to seek a 20 hour group experience in the community, which must be facilitated by a Licensed Mental Health Practitioner. Prior to doing an outside group experience contact Irene Harper, (402) 554-3648 to assure it meets requirements.

## NCA PAST PRESIDENT SCHOLARSHIP AWARD

The Nebraska Counseling Association continues to celebrate the awarding of its Past President's Scholarship to a graduate student who is pursuing a master's degree in Guidance and Counseling. This scholarship fund was established some years ago when a memorial donation was received after the death of Eldon Heskett, an NCA past president. Since that time memorials from families and friends of deceased NCA members have been deposited to this fund. In addition, on April 29, 1989, NCA took action to allocate earned interest from all NCA accounts to be transferred to the Past President's Scholarship Fund to indicate support for this project. The first award was made in 1995. The NCA Executive Board has determined that three \$300 scholarships will be awarded in 2013.

A committee of three former Presidents will select winners from applicants who have submitted appropriate documentation to NCA. Past winners may reapply for a second scholarship, however priority will be given to applicants who have not previously received a scholarship. If you have any questions, please contact Past President Doyle Daiss at doyledaiss@yahoo.com who will chair this year's selection committee.

Eligibility for this award includes:

- 1. Applicants must be accepted into a graduate counseling program in the state of Nebraska with the intention of continuing in the program until they complete a master's degree.
- 2. Applicants shall be members of NCA.
- 3. Applicants shall have a Grade Point Average of at least 3.5 on a 4-point scale.
- 4. Applicants shall create and submit an application letter (limit 2 pages) that clearly indicates their intention to continue in the program and express their thoughts about their motivation to enter the counseling profession.
- 5. Applicants will demonstrate financial need in some way.

All Eligible Graduate Students are encouraged to apply. Scholarship winners will be presented with checks at the state conference lunch on <u>*Thursday, October 3, 2013.</u>* Application letters must be postmarked or emailed to necourseling@gmail.com by <u>September 2, 2013</u> to be eligible.</u>
