
continues to progress smoothly. Please feel free to stop in my office or email at any time with questions, concerns, or suggestions (dkissinger@unomaha.edu).


- Attended, along with Mr. Richards, the American School Counseling Association conference in New Orleans.

Potential funding for students interested in attending a professional conference can seek support and can make travel requests in two locations. Students who will be presenting their research/projects are more likely to receive funding, than those who are only attending a conference. These requests should be made well in advance of the conference.

- A proposal with a detailed budget (summary of presentation, conference name, registration fees, airfare, etc..) should be submitted directly to the Dean of the COE.
- Information on other sources such as the University Committee on Research & Creative Activity (GRACA) and funding agencies exterior to the University can be obtained from the Office of Research and Creative Activity (ORCA).



Advocacy Corner

Advocacy is an important responsibility for professional counselors. It's how we gain professional recognition and identity, but is also central to how our licensing/certification is designed-which governs who/how we can serve our students and clients. There are opportunities to become advocates at all levels. In our department, CSI and the department chair committee are two examples. State organizations also offer a range of opportunities (NCA, NSCA, etc.).

You can also become knowledgeable about upcoming legislation that affects you as a future counselor by going to the websites of ACA, NBCC, and your respective specialization organizations (AMHCA, ASCA, NASPA, etc...).

CMH Internship Info

When it comes time for your internship experience, it is your responsibility to contact sites of interest and secure your internship. There are many opportunities available in the community. If you are uncertain of where to begin your search, check out the department website for a site list to get you started (http://www.unomaha.edu/college-of-education/counseling/graduate/forms-documents.php). Your advisor is available to speak with you about marketing yourself to site supervisors and to answer any questions you may have.

A few key points to remember:

- Plan to do your internship experience at the end of your program. It will best position you to transition into the job market.
- Aim to find a site that best suits your interests.

Policy Update: NCE

The NBCC, has recently changed the procedure for applying and registering for the National Counselor Exam:

- Application and registration will now be an online process. Dr. Kissinger will send out a notice on the listserv.
- 2. Once each fall and spring, the department will submit a roster of students to the NBCC for students eligible to take the NCE exam through NBCC. Eligible students include:
 - Students who are/will be enrolled in COUN 8260 (Advanced Internship).
 - Students enrolled in COUN 8250 who plan to graduate the summer.
- 3. Students will request permission from Dr. Kissinger to be registered for the NCE through NBCC.
- 4. Dr. Kissinger will verify their enrollment status (COUN 8250/8260/ summer graduation).
- When verified, students will be placed on the roster and submitted to NBCC.
- 6. NBCC personnel will verify the roster and contact each student with official permission and directions for registering for the NCE.
