DEPARTMENTAL ORGANIZATIONAL CHART


Unit Mission Statement: (Graduate)

Through a rigorous, evidence-based curriculum designed to train critical thinkers and reflective practitioners, candidates are prepared to work with diverse clients across multiple professional settings and engage and remain active as advocates and future leaders within and for the counseling profession and those we serve.

Unit Value Statement:

The Department of Counseling provides a student-centered, wellness-oriented curriculum that focused on the development of ethical, competent, and reflective counseling practitioners in the Clinical Mental Health (CMH), School Counseling (SC), and Student Affairs in Higher Education (SAHE). Graduates are prepared to sit for all state and national licensure and certification exams in their respective areas. Employment opportunities for graduates is excellent, with graduates finding employment in public and private clinical settings (CMH), in critical shortage areas in the public school systems (SC), and across public and private higher education institutions (SAHE). The Counseling Department also routinely sees graduates matriculate on to doctoral programs in Counselor Education, Counseling/Clinical Psychology, and Students Affairs/Higher Education Administration.

Enrollment in the UNO Counseling Department has shown consistent increases in the CMHC and School Counseling programs between 2015 and 2017. The smaller enrollment numbers in 2016 across the board, but particularly in the CMHC program, were based on the need to better align the faculty/student ratios per CACREP. As noted, enrollment in the CMHC rose substantially as another tenure-line assistant professor was hired. The current enrollment in the CMHC is at or near capacity and the CMHC program continues to admit between 45-50 new CMHC students per year.

As noted, enrollment in the CMHC program has increased a substantial 39.47% from 2015, from 152 to 212. The lowest enrollment numbers in 2015 were intentional and designed to better align with CACREP faculty/student ratios. The hiring of another assistant professor in 2015 was the impetus increasing enrollment after 2015. The CMHC specialization is at or near capacity given the current faculty/student ratio and make-up of the faculty and the goal of the department is to maintain this solid enrollment status for 2018.

Enrollment numbers for the School Counseling specialization have also increased, albeit not as significantly. In August 2017 the state of Nebraska adopted an alternative endorsement for school counseling. This endorsement provides an “alternative path” for individuals who do not have a valid NE teaching endorsement, two years of teaching experience, and/or a degree in education to attain endorsement as a school counselor. The department has already seen increased interest in this option and has collaborated with Teacher Education to create a curriculum aligned with the NDE requirements for the alternative endorsement. Ultimately, the department sees the School Counseling specialization as an area for enrollment growth given the current enrollment numbers and new opportunities afforded by the new/alternative endorsement.

Enrollment in the Student Affairs in Higher Education Program (SAHE) has increased from 5-17 between 2015-2017. The SAHE is a counseling-based student affairs program as opposed to other programs that maintain a more higher education administration focus. Despite clearly highlighting this focus to prospective students, the previous two years have included student feedback attesting to an interest in more higher education administration courses. Currently, the department does not expect additional changes to the current, counseling-based curriculum as our program is a) consistent with other counseling-based graduate program curriculum in Student Affairs and b) provides an intentional distinction in focus from the higher education focused program at UNL.

Demographic data over the 2015-2017 period illustrates the importance on focusing energy on increasing enrollment among minority/underserved student populations. To that end, the department created new tracking documents and has made the recruitment of minority and underserved students a primary departmental goal for 2019 with an overall goal of increasing the overall percentage of enrolled and active minority/underserved students by 10%.

M.S. in Clinical Mental Health Counseling

M.A. in Clinical Mental Health Counseling (thesis)

Program Description:

The 60 credit M.S. degree with a concentration in CMHC includes the coursework and field experiences (practicum/internships) required for licensure as a mental health professional in Nebraska. Graduates of the CMHC concentration will have also completed the academic requirements for the Alcohol and Drug Counseling Requirements (LADC) in Nebraska.

The 66 credit M.A. degree with a concentration in CMHC includes a thesis in addition to the coursework and field experiences (practicum/internships) required for licensure as a mental health professional in Nebraska. Completion of a 6 credit hour thesis sequence is also required. Graduates of the CMHC concentration have also completed the academic requirements for the Alcohol and Drug Counseling Requirements (LADC) in Nebraska.

This concentration provides an opportunity to obtain experience in original research through completion of a thesis. Students considering this option should have a strong interest in research methodology and a specific content area of research. Students must follow specific guidelines and timelines according to UNO Graduate Studies, the UNO Counseling Department, semester schedules, and the schedules of thesis committee members. The Fall 2017 semester saw the implementation of the revised core and specialization curriculums.

Revisions to the core counseling courses (effecting CMHC & SAHE concentrations) included:

- COUN 8020: Introduction to Counseling (1 credit) and COUN 8500: Consultation (2 credits) became COUN 8010: Introduction to Counseling (3 credits)

- COUN 8306, COUN 8316, and COUN 8406: Counseling Techniques I, II, III, respectively (all 1 credit courses) became COUN 8400: Advanced Counseling Theory & Techniques (3 credits)

Revisions to the M.S. and M.A in CMHC concentration curriculum included the following:

- COUN 8270: Group Techniques (1 credit) and COUN 8370: Group Theory & Practice (2 credits) became COUN 8360: Group Theory and Techniques (3 credits).
- COUN 8686: Med & Psychosocial Aspects of AD & Addict (3 credits) and COUN 8696: Assess & CM in SA (3 credits), both currently required CMHC courses, became electives and were replaced in the curriculum by the following required courses:
 - COUN 8700: Counseling Children & Adolescents
 - COUN 8800: Clinical Mental Health Counseling

Degree Offerings:

M.S. in School Counseling

M.A. in School Counseling (thesis)

Program Description:

The 48 credit M.S. degree with a concentration in School Counseling includes the coursework and field experiences (practicum/internships) required for certification as a School Counselor in Nebraska. It is important to note that the state of Nebraska currently requires two years of teaching experience prior to holding a position of school counselor, with limited exceptions.**

**Alternative School Counseling Endorsement implemented August 2017, which eliminates two year teaching requirement for those without a valid teaching endorsement in NE or degree in education and subsequent to completion of appropriate additional credits. Applies to M.S. and M.A. degrees.

The 54 credit M.A. degree with a concentration in School Counseling includes the coursework and field experiences (practicum/internships) required for licensure as a School Counselor in Nebraska. The M.A. degree requires completion of a 6 credit hour thesis.

This M.A. concentration provides an opportunity to obtain experience in original research through completion of a thesis. Students considering this option should have a strong interest in research methodology and a specific content area of research. Students must follow specific guidelines and timelines according to UNO Graduate Studies, the UNO Counseling Department, semester schedules, and the schedules of thesis committee members.

- COUN 8670: Post-secondary transitions and Career Readiness was added as a required SC course beginning Fall 2017.
- COUN 8700: Counseling Children and Adolescent (3 credits) was added as a required SC course beginning Fall 2017.

M.S. in Student Affairs in Higher Education

M.A. in Student Affairs in Higher Education

Program Description:

The 36 credit hour M.S. with a concentration in SAHE includes coursework and field experiences for individuals interested in careers in higher education. This concentration is *not* CACREP accredited. The 42 credit Masters of Arts with a concentration in Student Affairs in Higher Education requires the completion of a 6 credit hour thesis option.

Thesis Option (M.A.)

The thesis option (M.A.) includes an additional 6 hours of graduate credit applied to the 36 credit Student Affairs in higher education concentration. This option provides an opportunity to obtain experience in original research. Students considering this option should have a strong interest in research methodology and a specific content area of research interest.

No revisions were made to the SAHE concentration. However, SAHE students were affected by the following changes in the core counseling curriculum:

- COUN 8020: Introduction to Counseling (1 credit) and COUN 8500: Consultation (2 credits) became COUN 8010: Introduction to Counseling (3 credits)
- COUN 8306, COUN 8316, and COUN 8406: Counseling Techniques I, II, III, respectively (all 1 credit courses) became COUN 8400: Advanced Counseling Theory & Techniques (3 credits)

*All student complaints were anecdotal and associated with an adjunct instructor’s grading system. Specifically, students were frustrated with the ambiguity of an assignment where points appeared to have a significant influence on their final grade. The department chair listened to the student concerns, but recommended students address the issue in the form of a formal grievance. No student filed a formal grievance.

**Students preferred to email complaints directly to department chair. Upon receipt, the instructor was notified of the student complaints and the basis for the complaints. The (adjunct) instructor and chair processed each key element of the complaint and designed a plan of action, including a formal in-class evaluation of the instructor’s course. At different intervals following this discussion, the department chair solicited feedback from the instructor and

complainants, with both reporting an improvement in instruction and a more positive learning environment.

***Student complaints were all informal, yet centered on the overlap of courses and the challenges of work/life/school balance, and the challenges of completing the department mandated “group experience”. These concerns have been integrated into faculty discussions and, to the best of the department’s ability, have been integrated into the department’s new 3 year course schedule and scheduling of the group experience to allow SC, CMHC, and SAHE students to schedule their group experience prior to taking their respective group counseling course.

Department Highlights

1. CACREP Accreditation (thru 2023 for CMHC & School Counseling)

Appendix B: Clinic and/or Center Reports

The UNO Community Counseling Clinic had an excellent year, with consistent, substantial increases and services provided and community awareness. For example, between the Spring 2017 and Fall 2017 semesters, the clinic saw a 31.4% increase in clients served, reduced client cancellations, and maintained a no-show rate that aligns with most community-based outpatient mental health clinics. These numbers are detailed below:

Services

The clinic is among the few low cost providers of mental health counseling providers in the Omaha metro region. Following the completion of a marketing analysis by UNO MBA students in 2016, the clinic increased fees to \$10 for individual sessions and \$20 for couples sessions. This increase has been easily absorbed by clients and, as indicated by our numbers, has had no discernable bearing on consumer access to the services provided by the clinic. Importantly, the consistent flow and mix of UNO student and community-based clients has been an excellent source of training for COUN 8220 (practicum) students who consistently maintain individual case-loads between 6-10 clients.

Referral Sources

The clinic's main referral sources remain "word of mouth" and internet searches ("affordable counseling" or "low cost counseling"). However, community based agencies are increasingly aware of our clinic through outreach by the clinic director and clinic coordinator. In the past year, for example, community outreach has resulted in the clinic becoming a consistent referral source for clients from Metro, OneWorld, LFS, Nebraska Family Collaborative, Omaha Correction Center, the WCA and Methodist. As always, due to the training element of the clinic, clients with issues considered too complex for practicum level students are reviewed by the COUN 8220 instructor and, when necessary, the clinic director.

Marketing

As in the past, the clinic coordinator, together with the counseling department's graduate assistants, place flyers advertising the clinic in approximately a dozen local cafes and coffee shops. The clinic coordinator also updated the clinic's internet presence on several fronts. First, the clinic was listed on www.opencounseling.com, a free database for low-cost counseling services, and one of the first hits when "low-cost counseling Omaha" is Googled. A Facebook page for the clinic, with the help of the COE communications department, oversaw the correction and update of an erroneous listing of the clinic in the Douglas County Resource Guide (published by the school of social work at UNO). The clinic coordinator and clinic director met with several leaders at community agencies and across campus to promote the clinic's presence on campus and provide flyers and business cards. Importantly, the clinic director, clinical coordinator, and practicum instructor maintain active communication with the mental health professionals at UNO's Counseling and Psychological Services so as to maintain an ongoing source for expanding access to low cost mental health services for UNO students and staff.

2018 Goals

1. Begin transition to re-branding clinic as "clinical training and research clinic".
2. Establish a plan with NU Foundation to secure funding for a) naming rights to the clinic and b) clinical supervision for COUN 8220 students, and c) funding for in-house research.
3. Officially track clinic referral sources
4. Update and revise clinic policy and procedure manual
5. Update clinic's documentation
6. Update and revise clinic website
 - a. Create downloadable documents for clients

Overall, the 2017 academic year was a tremendous success for the UNO Community Counseling Clinic and we look forward to focusing on continuing to provide excellent low cost counseling services to members of the community and quality training for UNO clinical mental health students.
