### **Teaching Program Alternative Permit Information and Requirements**

- 1. Requirements to begin working as a school counselor with the Teaching Program Alternative Permit:
  - Completion of 75% (36 credit-hours) of the School Counselor endorsement coursework completed (or equivalent coursework and/or degree verified by the UNO Counseling department).
  - o 50% (6 credit-hours) of approved teacher education program coursework.
  - Employment verification. Please send to unocertification@unomaha.edu

Please provide last name, first name, middle initial, NUID, and the area of endorsement, degree or coursework in your notification. UNO Certification will process the verification paperwork for enrolled UNO students at the time the **Teaching Program Alternative Permit** application is submitted to NDE and completion of all requirements of the permit have **been verified by the Counseling department**.

The teaching program alternative permit is valid for two (2) years and is nonrenewable.



### **Praxis Test Requirement**

Successful completion of the School Counselor Praxis Subject Content Test (5422) are required for <u>full School Counseling certification</u>. Please send the scores to UNO and NDE.
