**Scott A. Carlson** received a bachelor of science in criminal justice degree from UNO on the Lincoln campus in 1992. He is the statewide coordinator for problem-solving courts for the Nebraska Supreme Court administrative offices. Carlson began working in this position in 2005 and is responsible for organizing and supporting the 21 existing statewide problem-solving courts and assisting the establishment of problem-solving court services throughout Nebraska.

Fiene serves the UNO community as the associate vice chancellor for technology.
