SCHOOL OF CRIMINOLOGY & CRIMINAL JUSTICE

The School of Criminology and Criminal Justice (SCCJ) prides itself on delivering high quality education that emphasizes the critical role of science in informing criminal justice policy and practices. Our faculty members are actively engaged in research with our criminal justice agency and community partners in Nebraska and across the U. S. Our goal is to be an innovative leader in providing a high quality, 21st century criminology and criminal justice education through research excellence and community engagement. This vision focuses on enhancing the learning opportunities available through the SCCJ while maintaining our position as a valuable and accessible resource for our community partners.

Retaining our prominent role as a well-respected leader among criminology and criminal justice programs is critically important and reliant upon the fantastic successes of our SCCJ students, faculty and alumni. Our reputation helps open additional doors for our students as they take their first steps as the next generation of criminal justice professionals. Our ongoing emphasis on delivering high quality education at the bachelors, masters and doctoral level has resulted in significant recognition as one of the most affordable programs, and one of best programs in the country. Opportunities for learning both inside and beyond the classroom are outstanding thanks to our broad network of partners. We are particularly proud of the *U.S. News and World Report* rankings that listed our online master's program 3rd in the country. Our bachelor's program received high accolades as well. Currently, we educate over 900 undergraduate majors on the Omaha and Lincoln campuses, and over 100 graduate students in Omaha.

The SCCJ is engaging in an important initiative to launch our first of four Signature Areas of Excellence focusing on Youth and Adult Victimization. Building upon our existing program strengths and community partnerships, we will broaden our student learning opportunities in this area through new coursework, bolster our capacity for engaged research through the addition of two new faculty members beginning fall 2018, and enhance our position as a resource to the greater Omaha community and beyond.

This year, we continued to experience growth among our faculty and students. The SCCJ was fortunate to add a new faculty member Dr. Justin Nix who is a nationally recognized expert in policing research. We received a federally funded grant from the National Institute of Justice (NIJ) won by Dr. Ben Steiner and Dr. Joe Schwartz totaling almost \$900,000. Graduate students will also have the opportunity to participate in this important research that will better inform the field regarding physiological reactions to stress among corrections professionals.

We continued to enhance our relationships with alumni, many of whom are leading successful criminal justice careers. These alumni remain engaged with our students and faculty as representatives of their agency, as guest lecturers, by attending at our professional development events, as a participant in our fall golf tournament fundraising event, and attending our spring SCCJ Awards Luncheon.

UNO SCCJ Organizational Growth and Successes

New Faculty Additions this academic year

Dr. Justin Nix joined the SCCJ as an assistant professor in August 2017. Nix earned his Ph.D. in Criminology and Criminal Justice from the University of South Carolina in 2015. His research interests revolve around policing; in particular, police legitimacy, procedural justice, the "Ferguson Effect," and police use of force. He is a member of the Crime and Justice Research Alliance expert panel, specializing in procedural justice, police legitimacy, and police use of force. Dr. Nix's work has appeared in many of the top peer reviewed journal article and book chapters including *Justice Quarterly, Law and Human Behavior, Journal of Criminal Justice,* and *Journal of Quantitative Criminology.* His work has also been featured in the London School of Economics *United States Politics and Policy Blog (USAPP), USA Today, The Washington Post,* and *The Huffington Post.*

Success in hiring faculty for the 2018-2019 academic year

Dr. Tara Richards joins the faculty in August 2018. Her primary areas of research includes intimate partner violence, sexual assault, and the role of gender in criminal justice system processes. Richards' current research focuses service utilization among survivors of intimate partner violence and suggested best practices for campus sexual assault. Dr. Richards also serves as a co-investigator on a process evaluation for Colorado's Domestic Violence Offender Management Board. Some of Richards's previous research has examined intimate partner homicide and capital punishment, and the role of social support in adolescent dating violence perpetration and victimization. Richards's recent research has been published in *Child Abuse and Neglect, Crime & Delinquency, Journal of Criminal Justice,* and *Law and Human Behavior* and she is the co-editor of the book, *Sexual Victimization: Then and Now.* Her research on media presentation of intimate partner homicide was a finalist for the "2013 article of the year" in the journal *Violence Against Women.*

Teresa C. Kulig is an incoming Assistant Professor. She received her Ph.D. from the University of Cincinnati. Her research focuses on a range of issues including human trafficking and child exploitation, theories of victimization, examining rape myth acceptance, evaluating public perceptions of sexual misconduct allegations against President Trump, and analyzing racial bias in laws named after crime victims. She has published in *Justice Quarterly*, the *Journal of Criminal Justice Education*, *Victims & Offenders*, and the *Journal of School Violence*. Teresa is currently studying human trafficking in 22 of the largest U.S. cities to identify incidents of sex and labor trafficking. The goal is to illuminate the nature of the trafficking enterprise so as develop evidence-based methods of prevention.

Graduate students are active in research and education

Twenty doctoral students were actively engaged in research projects supported by graduate assistantships from the Nebraska Department of Correctional Services, the Nebraska Center for Justice Research, Iowa Department of Corrections, Douglas County Corrections, Center for Collaboration Science, Juvenile Justice Institute and internal grants.

SCCJ's Ph.D. students:

Community and Professional Engagement Activities

The School presented a series of workshops that explored opportunities for criminal justice reforms and changes expected to generate these reforms. Each workshop emphasized the importance of a healthy criminal justice culture driven by excellence in policy development, carefully crafted training, and inspired leadership. Panelists engaged the audience in discussions surrounding leadership and how core practices can generate significant improvements in agency performance.

Body Worn Camera Technology: A two-day workshop was co-sponsored by the Bureau of Justice Assistance and Arizona State University at UNO.

Jail and Prison Litigation Workshop 52 participants, included Judge Laurie Smith-Camp and Harold Clarke, NE ACLU Director.

Military Veterans in the Criminal Justice System: From Arrest to Reentry in Douglas County provided participants with a working knowledge of both the Douglas County Department of Corrections Veteran's Housing Unit and the Douglas County Veteran's Treatment Court.

Brain Injury and Domestic Violence was held in partnership with the Brain Injury Alliance of Nebraska featuring panelists from the Brain Injury Alliance of Nebraska, University of Nebraska Medical Center Department of Neuropsychology, and the Women's Center for Advancement. Participants learned about the prevalence of domestic violence, brain injury and co-occurring conditions, brain injury screening tools, and community resources.

The SCCJ continued their involvement and support of other community organizations and events including the First Responders Foundation 9/11 Memorial Benefit Event, Metro Chief's Association, and the Omaha Police Foundation Officer of the Year luncheon. The UNO SCCJ Awards Luncheon held on April 13, 2018 attracted record attendance of over 250 people from the university, criminal justice agencies and community organizations.

The 22nd annual fundraiser "Jailhouse Scramble" was a huge success. The September 15 event held at Tiburon Golf Course drew more than 80 golfers and netted almost \$7,000 for student scholarship support. More teams competed than in years past. We gained new corporate sponsors and realized higher levels of sponsorship from many of our loyal sponsors who have been supportive of the SCCJ. Some of the funds raised from the event were used to endow the Dennis Roncek Memorial Fellowship fund.

GRACE ABBOTT SCHOOL OF SOCIAL WORK

The faculty and staff of the Grace Abbott School of Social Work (GASSW) had a most productive year, with the launch of our Continuing Education Program among the highlights. Also, the proposal to offer an online Master of Social Work (MSW) program was approved. GASSW will offer the MSW program in three formats: the face to face program on the UNO campus, the weekend format of partial online and partial face to face courses taught on the University of Nebraska at Kearney (UNK) campus, and the totally online MSW program beginning in fall 2019.

Enrollment remains strong for current Bachelors of Social Work (BSW) and MSW programs, and we graduated 18 rurally based MSWs from the off campus program in addition to 37 BSWs and 52 MSWs this academic year. Since the inception of the off campus MSW program in 2009, GASSW has added over 60 behavioral health practitioners to rural and underserved areas in Nebraska.

CENTER FOR PUBLIC AFFAIRS RESEARCH

The Center for Public Affairs Research (CPAR) was established in 1963 as the Center for Urban Studies. Its initial mission was to address urban problems and information needs. It became part of CPACS when the college was created in the early '70s. Over the years CPAR has gone through several name changes and personnel changes that have modified its mission. In October 2017, a periodic program review of CPAR was conducted with a recommendation that CPAR be retained.

In 2017-18, CPAR received more than \$550,000 from grants and contracts. In addition to CPAR staff, these grants and contracts provided summer funding, course buyouts, and/or travel funds for 5 faculty members, funding for 2 doctoral students, and funding for 8 graduate student workers.

During the past year, CPAR continued its work with Nebraska Department of Transportation (NDOT) focusing on rural transit in Nebraska and also continued its State Policy Initiative with the Nebraska Legislature's Planning Committee. As part of its NDOT grant, CPAR maintains an office at the Innovation Campus in Lincoln. 2019 will mark the 30th anniversary since CPAR took over as the lead agency for the Nebraska State Data Center program.

We will be entering into a partnership with Library Archives to house the CPAR archive and to audit the holdings to assure that all publications are available in Digitalcommons.

We have a total of 646 documents currently available; receiving 6,265 downloads between May 2017 and April 2018 from more than 110 countries.

WILLIAM BRENNAN LABOR STUDIES INSTITUTE

The need to both train labor leaders about the knowledge and skills required to promote and defend meaningful workplace democracy continues to grow across the state of Nebraska. Moreover, the history of the labor movement's many contributions to the well-being of wage earners inside and out of the labor movement grows as well.

We faced a challenge to effectively and efficiently perform those duties with a reduced staff. The fulltime educator position remained unfilled this year and when our administrative assistant Susan Hayes retired, the position was eliminated for budget reasons.

When one door shuts, another opens. The Institute has entered into contracts with Metropolitan Community College (MCC) and Labor United, Inc. to help provide a labor history curriculum for MCC students taking classes in their Construction Education Center building. We are also investigating the possibility of offering shorter lectures to Omaha Public Schools students who show an interest in career education.
