## Description

This training offers a clear overview of Medication-Assisted Treatment (MAT), highlighting its effectiveness, addressing common stigma, and outlining the treatment process to promote informed, compassionate care for individuals with substance use disorders.

## Learning Objectives

- Explain what Medicated Assisted Treatment is, including its definition as an evidence-based approach combining medications with counseling and behavioral therapies to treat substance use disorders, particularly opioid and alcohol addiction.
- Demonstrate the effectiveness of MAT in reducing withdrawal symptoms, cravings, overdose risk, and improving long-term recovery outcomes, supported by clinical data and patient success stories.
- Clarify common stigma by emphasizing its medical foundation and role in stabilizing brain chemistry for sustainable recovery.
- Provide an overview of how MAT works, including eligibility, medication options, therapy components, and the role of healthcare teams in personalized care plans.
