Executive Summary

This report is the product of collaborative efforts from the Nebraska Center for Justice Research, the School of Criminology and Criminal Justice, Industrial and Organizational Psychology and the Criminology and Criminal Justice department at Portland State University. The purpose of this report is to provide an overview of the importance of using evidence-based practices and programs, examine the quantity and needs addressed by adult criminal justice programs, and provide a snapshot of operating evidence-based programs throughout Nebraska. This report provides findings related to the discovery of programs and a review of branded programs operating in Nebraska.

Product 1 – Inventory of Nebraska Programs

Hundreds of programs and services are offered throughout Nebraska to assist the adult justice-involved population. The research team gathered a list of these programs through an examination of publicly available online sources on criminal justice agency websites. Hundreds of programs were identified after a review of these sources. Given the substantial quantity of programs, the researchers utilized a methodology to examine the programs and practices most appropriate for review and evaluation. Programs developed in Nebraska, and not yet rigorously evaluated, were determined ineligible for a more extensive review and should be examined in more depth under different guidelines. Upon conclusion of our review determination, the researchers identified 714 eligible programs and services in total.

Product 2 – Branded Programming Review

After a list was compiled, programs were sorted into two categories: homegrown (621) and branded (93). Peer reviewed research was gathered on the branded programs (frequently used synonymously with 'evidencebased programs' or 'off-the-shelf programs' ...these are programs that tend to be well-known brand names with research evidence to backing their use). Based on the results of the acquired studies, programs were ranked on their ability to move participants towards desired outcomes, including reducing recidivism, increasing meaningful employment, reducing substance abuse or addiction symptoms, and improving overall health and well-being. Using the ranking criteria located in Table 3, programs were classified as either evidence-based (11), research-based (18), promising-practice (6), consensus-based (13), or no evidence (45).

Future Proposed Deliverables – Describe and Review of Program Practices


Although this report lays the foundation to encourage more agencies and program providers to adopt evidence-based programs, additional work should examine whether program provider practices are in line with program protocols and otherwise best practices. Therefore, the research team proposes doing a component analysis outlined by Campbell et al. (2018), which includes gathering program manuals and interviewing/ survey program staff to examine if practices are consistent with recommendations.

Introduction

Several programs and services have been developed in recent years to assist the justice-involved population succeed as law-abiding citizens. Some of these efforts have been examined empirically and are associated with desired outcomes such as desistance from crime, improved mental health and well-being, and reductions in violent behavior. 'Evidence-based' programs or practices (EBPs) have demonstrated effectiveness in achieving their goals as evidenced in high quality outcome evaluations (National Institute of Justice, 2021). These outcome evaluations use standardized scientific methods that yield causal evidence (National Institute of Justice, 2021). Many states are engaging in evidence-based policy making, as these programs and practices are found to be more cost-effective (Pew, 2017).

State governments and researchers are finding it helpful to examine the extent to which programs, especially state-funded programs, are evidence-based and which are not (Campbell et al., 2018; Wiener et al., 2014). Following these inquiries, the current study examined operating programs and services targeted for adult, justice-involved populations and ranked them on their ability to achieve intended outcomes. Figure 1 describes the steps taken to complete this project and produce deliverable findings.

Product 1: Program Discovery

Several programs and services seek to address the needs of justice-involved individuals throughout Nebraska. These programs are provided by justice agencies such as corrections, parole, probation, and community programs. Using publicly available information, the research team compiled an extensive list of programs and services offered across the state. The websites containing this information are located on Table 1. The program information was stored in a spreadsheet and included the name of the program or service, referral source, sub-program type (clinical, non-clinical, vocational and life skills, etc.), agency identified needs, EBP inventory identified needs, state location (city, villages), facility locations, community locations, and where the program or service were retrieved. The aggregated agency identified needs, indicated by the STRONG-R and EBP inventory, are presented in Table 2., which demonstrates the similarities and differences between assessment tools used by different Nebraska agencies relative to the general needs developed to complete this project.

Our research team acknowledges that some program and service information may not be publicly available

online, rather it may be available upon request from the agencies. The decision was made to intentionally limit the scope of this inquiry for a few important reasons. First, we decided to not request a list of programs to ensure no burden was placed on justice agencies with our inquiry. Second, we wanted to examine publicfacing information and allow providers to reflect on information average citizens could access with an internet connection. Additionally, family members and friends occasionally try to assist justice-involved individuals, thus it is helpful to utilize what is available and recommended online.

A total of 714 programs and services that aim to serve the needs of the adult justice-involved population were identified during program discovery. Before ranking the extent to which programs are evidenced-based, the research team identified which programs were 'branded' or 'off the shelf', and which were considered 'homegrown'. Branded or off-the-shelf programs are those that have gained traction, regionally or nationally, because of the positive outcomes or anecdotal evidence that supports the program. Homegrown programs, on the other hand, are those developed locally, often relatively recently, and do not yet have evidence beyond anecdotal accounts to demonstrate effectiveness. A program was coded as branded and moved to the next stage of review Branded, if it addressed one of the following criteria: Considered 93, 13% clinical treatment by NDCS, is a referred program by the National Institute of Justice (NIJ) Crime Solutions Rated Programs¹, is a referred program by the U.S. Department 714 of Health & Human Services Substance Abuse and Mental Health Services Administration (SAMHSA) Resource Center², Programs is found on the Department of Justice (DOJ) National Discovered Institute of Corrections (NIC) Annotated Bibliography³, has in Nebraska information or evidence about the program readily available on Google search engines. Using these criteria, the research team classified 93 programs as branded (13%), and 621 programs as homegrown (87%). Homegrown, 621,87%

There are numerous programs and services available for justice-involved populations but knowing which to prioritize for a population can be challenging for administrators and policy makers allocating fundina. To




Figure 2. Decision Tree Analysis for EBP Project

identify best program practices requires an extensive examination of evidence while paying close attention to methodological differences within empirical findings (Campbell et al, 2018). To assist interested parties with this process, the researchers gathered several empirical studies, operationalized ranking criteria (described in Table 3), and categorized the programs based on said criteria. Figure 2 also shows all the decisions made up until this stage of the project. This product provides those with vested interest insight into the proportion of programs operating that may result in desired outcomes.

The researchers sought out published findings on each of the branded programs and reviewed searches for quality assurance. A total of 115 empirical studies were gathered to inform the EBP ranking categorization. For each study, researchers noted the author, year, title, journal, sample size, program focus, whether the study evaluated the program or a related practice, target population, outcome measure, significant variables, effects on outcome variables, and whether the researchers in the study were associated with the program creators to account for conflicts of interest (e.g., allegiance effects). All studies were published between 1987 to 2021. Outcome measures included attitudes, reconviction, reincarceration, rearrest or new charge, or a specific behavior or intermediate outcome (e.g., drug use).

Issues and Limitations



It is important to interpret these findings within the appropriate context of how much the research team's efforts were confined due to the stated focus on publicly available information. Consequently, the ranks provided here represent the minimum number of quality factors that could be considered for each program. It is possible that additional evaluations conducted by/for NDCS may produce findings with the methodological rigor necessary to exceed the outlined criteria and therefore provide evidence that may increase a program's rank. Without such studies, however, the rankings are subject to the information available via internet searches.

Similarly, our rankings provide a more accurate portrayal of program effectiveness. Sans a direct evaluation, each program should be assessed for the components applied in relation to the components studied. For instance, it is not uncommon for a state corrections agency to remove a component (e.g., role playing) from a program that has been shown to be effective at reducing recidivism (e.g., cognitive behavioral therapy). This is often due to not having adequate resources to provide the full program (e.g., staffing) as prescribed by the manual. In the literature, these adaptations are commonly described as failing to maintain 'program fidelity', or simply not delivering the program as it is intended to be delivered. Such a change is critical to a program that only has five or six components initially. Unfortunately, a component inventory was not feasible in our analysis of public-facing information, as it requires interviews and/or program observations.

It is also important to recognize that some programs assessed were ranked lower due to studies evaluations and a lack of methodological rigor. Many programs may have been evaluated, but the study's methodology was too weak to be included in the sample. It is often the case, particularly in a prison setting, that there are difficulties obtaining a comparison group for a program evaluation. This is understandable and can still be viewed as some meaningful evidence for changes in skills, attitudes or knowledge, however the evidence provided was not sufficient to determine a rank in relation to behavioral outcomes such as misconduct and recidivism. More importantly, without an adequate control/comparison group, study findings are vulnerable to selection bias that may result in invalid and unreliable findings. This, and the lack of research on similar populations, were common issues for studies to be removed from consideration, and consequently, programs were downgraded. The lack of research and weak methodology are prime reasons for agencies to implement their own quality assurance measures in addition to systematic and routine evaluations of programs using administrative data.

Discussion of Future Proposed Deliverables

implementing, and/or sustaining a program is - If at some point it worked somewhere will it work here, now? This is particularly critical for rehabilitative programming. Implementing rehabilitative programs that are ineffective is not only a poor allocation of scarce resources, it is a practice that offers a false sense of security to all vested interest holders in what should be an effort to reduce recidivism and victimization. Thus, it is critical to know if a program is actually based on methodologically-sound empirical evidence and focused on achieving important behavioral or attitudinal outcomes (i.e., has rigorously demonstrated effectiveness via strong scientific inquiry). This analysis provides the starting point for administrators and policy makers to understand if Nebraska's rehabilitative efforts are in a position to be effective at helping to keep the public safe and improve individuals" lives.

To improve the knowledge base of rehabilitative efforts in Nebraska, next steps and future deliverables must include further analysis of information. For example, extended efforts should include a degree of quality assurance regarding how programs are implemented. This can be completed via interviews/surveys with program managers and stakeholders. Similarly, future evaluation should include a way to capture the scope of programs offered via a component analysis, which is compared to that which has been outlined by developers. Finally, once it is determined that the programs offered in Nebraska are based in research, then the state must bring programs to scope in order to fully address the population's needs. This involves what's known as a gap analysis - identifying the service gap between existing program capacity and those services needed to address the populations needs. The necessary step for NDCS in completing a gap analysis is using the extant risk/needs assessment, the STRONG-R, to determine the extent that a given criminogenic need (e.g., substance use disorders) is evident within the NDCS population. Then, using information regarding program capacity, gathered via interviews with program managers and the component analysis, researchers may assess the degree to which available programs is provided in the necessary amount for the population, based on the prevalence of need.

The NCJR research team will continue to add to the literature on these programs via future evaluations. These evaluations will include a review of program materials, interviews with staff and participants to assess program fidelity, observations of programming, recidivism, and cost-benefit analyses.

As noted in other research on assessing and ranking programming (Cartwright & Hardie, 2012; Campbell et al., 2018), a fundamental question that all administrators and policy makers try to answer when identifying,

Appendix I. Listing of Programs and Services by Need Domain

This section provides a breakdown of the 626 individual programs and services compiled for this report⁴. As stated earlier, there are extensive programs and services provided across Nebraska and no one report can capture every resource available to justice-involved individuals. The programs and services documented in this section of the report are provided by NDCS and/or community-based agencies. Independent behavioral health providers were not included in this document. In addition, many communities can support justiceinvolved individuals through a wide variety of informal supports such as churches, food distribution programs, community centers, discount stores, community recreation programs, and many more. These supports are vital to an individual's success but are too numerous to name and are not in line with the programming defined in this report. Therefore, they were not included in the following lists.

The programs compiled were reviewed by the research team and assigned based on the primary domain need they aimed to impact. The location of program delivery is noted as well as the provider. Table 4 provides a key of acronyms used to note locations in the tables to follow. Many programs impact numerous domains and those are indicated in the "crossover" domain column in the listing.


NCJR staff completed a literature review to support rating educational programs on a continuum of evidencebased practices. This continuum ranges from the highest rating of evidence-based to a rating of no evidence. Higher ratings are for "branded" programs supported by extensive research, while lower or no rating indicates minimal, or no research has been done on this program. It is important to note that a program with no rating does not mean the program is not effective. The purpose of this brief is to provide an overview of programs and services available statewide, not to measure program effectiveness.

Appendix I.A: Attitudes and Behaviors

Programs Available by County



Significant research indicates that criminogenic attitudes and behaviors are strong predictors of crime (Andrews & Bonta, 2006, 2010; Bourgon & Armstrong, 2005; Duwe, 2018; Landenberger & Lipsey, 2005). Criminal attitudes and behaviors are some of the most studied criminogenic needs. Most validated risk/needs assessment tools gather information on individuals' attitudes and behaviors to refer them to treatments that address this domain.

There were 40 programs identified whose primary outcome was to assist individuals with this domain. Notably, most programs in this domain are offered by NDCS with 12 having some level of research-based support. Not all the research-supported programs are offered in every facility. 

Appendix I.B: Basic Needs

Programs Available by County



Communities and organizations across the state provide an extensive network of support to help individuals and families meet their basic needs. These typically fall into the bottom two levels of Maslow's Hierarchy of needs. This hierarchy is a common model in social science identifying the levels of needs individuals related to motivation. The first level is physiological needs, which include food, water, sleep, shelter, etc. The second level is safety, which includes physical and emotional security, health, stable housing, etc. Individuals re-entering their community must have these two levels of needs met to allow them to focus on the treatment and other issues that reduce recidivism. While basic support services have not been evaluated for being Evidence-Based, it is important to include them in case planning to meet the individuals' holistic needs and prepare them for success.

The programs and services listed below are not exhaustive of those that exist in the state. Nearly every community has faith-based organizations, food distribution programs, rental programs, discount stores, and a variety of opportunities that assist individuals and families to meet basic needs. Those listed in this report were included if they indicated a specific program provided by an organization. This list includes 193 programs to assist with food, clothing, housing, medical, legal, and other basic needs. Some have specific target populations such as veterans or young adults, while others serve everyone. The following table indicates the programs offered by facility and/or geographic location, the program provider, program rating⁶, and any additional criminogenic domains the program might address.



Significant research indicates that individuals who engage in GED and other educational programs are less likely to recidivate, and that poor educational outcomes are highly correlated to criminal behavior and recidivism. (Cecil et al., 2000; Brewster & Sharp, 2002; Nutthal et al., 2003; Zgoba, et al., 2008; Nally et al. 2012) This is known as a criminogenic risk factor. Most validated risk/needs assessment tools gather information on levels of education attained and educational outcomes such as discipline, learning disabilities, etc. Individuals whose criminogenic behavior is highly impacted by poor educational outcomes need opportunities to realize what is possible through their academic achievement. This may be through traditional schooling and degree completion, certifications, and/or other vocational paths.

Nebraska Department of Correctional Services (NDCS); community providers; and the network of Nebraska university, private, and community college educational institutions provide programming to assist justiceinvolved individuals in this domain. Most of the 54 educational programs listed are provided by NDCS and the network of higher education institutions in the state. Only a small number of community-based organizations offer additional educational support, which is often coupled with employment services. All NDCS facilities offer basic adult education classes. Course and program offerings provided by higher education institutions appear to vary by location and facility. There are many classes and opportunities through the university and community college network. Unless a class or program was unique a specific campus, only the educational institution is listed in the table below. The following table indicates the programs offered by facility and/or geographic location, the program provider, program rating⁷, and any additional criminogenic domains the program might address.



Appendix I.D: Employment

Programs Available by County



Significant research indicates that individuals who engage in employment training and other vocational skills programs are more likely to gain employment in the community (Duwe, 2015(a), 2015(b); Huiras et al., 2000; Wilson et al., 2005; Simon, 2005; Uggen, 1999). Employment has been identified as a criminogenic risk factor. Most validated risk and need assessments gather information on employment history and stability of employment. The principles of effective intervention suggest that providing employment training can reduce individuals' likelihoods of reoffending.

There were 82 programs identified whose primary outcome was to assist individuals with this domain. It appears that there is a wide array of training for trade-oriented jobs. Available programs also include training on how to acquire jobs (e.g., resume building and interviewing skills). Seven programs were identified as having some level of research support for reducing recidivism. The following table indicates the programs offered by facility and/or geographic location, the program provider, program rating⁸, and any additional criminogenic domains the program might address.



Significant research indicates that individuals who lack familial ties are highly correlated to criminal behavior and recidivism. (Tracy, 1987) This is known as a criminogenic risk factor. Individuals who have strong familial ties and family support networks have been commonly identified as inhibitors of criminogenic behavior (Brunton-Smith & McCarthy, 2017). Individuals whose criminogenic behavior is highly impacted by the absence of or weakened familial networks need opportunities and skills to strengthen these networks through appropriate programming.


Programs responsible for instilling healthy relationships and developing skills beneficial to a positive family environment were discussed in this domain. There was a total of 10 programs identified whose primary outcome was to assist individuals with this domain, however one program is reportedly no longer offered at this time. Four programs were designated with a ranking; with one program identified as a promising-practice for demonstrating methodological rigor and exhibiting evidence in reducing recidivism while two of were identified as no evidence programs. This domain of modalities largely focuses on two aspects-parenting and marriage skills. All family and parenting programs are found in the correctional setting throughout six facilities statewide. The following table indicates the programs offered by facility and/or geographic location, the program provider, program rating⁹, and any additional criminogenic domains the program might address.

Programs Available by County



Extensive research indicates that individuals with mental illness have increased likelihood to engage in criminal behavior, encounter the criminal justice system and recidivate (Roy et al, 2014; Skeem et al, 2014). This is known as a criminogenic risk factor. Most validated risk/needs assessment tools gather information on mental health and mental illness. Individuals with mental illness(es) who are in correctional facilities need proper programming that assists their management and treatment of their condition(s) (Fiftal & Alarid, 2018).

There were 144 programs identified whose primary outcome was to assist individuals with this domain. Onehundred-thirty-eight were classified as clinical, and six programs were identified as non-clinical. Nineteen of the programs used evidence-based principles such as screening/assessment, motivational interviewing, etc. This is accomplished through a variety of modalities including cognitive behavior groups, social support groups, individualized case planning, etc. Most of these programs are found in urban areas, however mental health programs have coverage in nearly every county. The following table indicates the programs offered by facility and/or geographic location, the program provider, program rating¹⁰, and any additional criminogenic domains the program might address. There are numerous individual independent mental health clinicians in the state. For this document, only agency providers are included.



Appendix I.G: Peers and Social Support

Programs Available by County



Extensive research indicates that the peer(s) an individual associates with is highly correlated to criminal behavior and recidivism. This is known as a criminogenic risk factor. Most validated risk/needs assessment tools gather information on peer associations. Individuals whose criminogenic behavior is highly impacted by peers need programming that assists them in identifying and seeking out pro-social support and activities. Pro-social support can be viewed as networks or groups of individuals who demonstrate positive and can inhibit criminogenic behaviors (Bellamy et al., 2019; Rowe et al., 2007)

There were 46 programs identified whose primary outcome was to assist individuals with this domain. It appears that NDCS offers Alcoholics Anonymous and Narcotics Anonymous in every facility, however, not every community offers these programs. Fifteen programs were identified as having some level of research support for reducing recidivism. The following table indicates the programs offered by facility and/or geographic location, the program provider, program rating¹¹, and any additional criminogenic domains the program might address.



Research indicates that individuals with substance abuse issues are at an increased likelihood to engage in criminal behavior (Sinha & Easton, 1999) This is known as a criminogenic risk factor. Most validated risk/ needs assessment tools gather information on levels of substance abuse and substance abuse-related issues. Prison and community-based substance abuse treatment can be effective in reducing recidivism (Belenko et al., 2013) Individuals whose criminogenic behavior is adversely impacted by substance abuse issues need opportunities to realize what is possible through in-patient and outpatient treatment, counseling, and support groups.

Programs impacting the criminogenic risk factors of substance abuse are discussed in this domain. There was a total of 66 programs identified whose primary outcome was to assist individuals with this domain. There was a total of nine programs that were evaluated and designated with a ranking. This is accomplished through a variety of modalities including in-patient and out-patient treatment facilities, social support groups, individualized case planning, counseling/therapy. Programs were located within facilities as well as throughout the community. Most of these programs are found in urban areas, however the substance abuse program has coverage in nearly every county with multiple locations in Omaha, Lincoln, North Platte, Lexington, and Hastings. The following table indicates the programs offered by facility and/or geographic location, the program provider, program rating¹², and any additional criminogenic domains the program might address.


