The resolution intends to add language into the syllabus regarding hate and bias and where students can report if they have witnessed or experienced this. President Ostler suggested that Vanessa keep us informed with updates to the resolution and asked for an AdHoc Committee to be formed from Faculty Senate to work with the student government on the plans for the resolution.*

    - 2. Update on University Calendar proposal: As of now, the UNO Academic Calendar will follow the originally published dates for the 2020-2021 academic year including all of the holidays and breaks. However, as you are all aware, I released a UNO faculty email summarizing the results of a Calendar Climate Survey in which UNO faculty essentially voted "no" on the possibility of a J-term

for the spring semester of 2021. While the general vote of "no" means that we will not be introducing a resolution to create a J-term opportunity for the spring of 2021; UNO faculty did show a substantial interest in more attention to this topic with the caveat that certain questions be address so that a more informed decision could be made if we wanted to explore the possibility of a J-term in spring 2022. One of the primary questions raised by faculty regarding a modified calendar with respect to a J-term was would it be favored by students. Last week, the UNO Student Government completed the results of a similar survey, which raised the possibility of a J-term and the resulting modified spring calendar a J-term would necessitate. Over a thousand students responded, with over 70% responding that they would favor the opportunities offered within a J-term. Given that the students responded so favorably, and that UNO Faculty responded that we should explore further if we could address critical issues, we will be looking into this possibility again in the fall, hopefully prior to Collective Bargaining. Questions such as contract obligations with respect to a modified calendar, compensation for J-term instruction, breaks/holiday concessions, and academic course preparation, will be outlined in detail and included in Collective Bargaining to address faculty concerns.

- 3. Assistant Vice Chancellor Edwards has asked that faculty publish Canvas Courses by August 20<sup>th</sup> so students have time to set a schedule and ask questions about course attendance expectations prior to the first day of class.

- 5. Update on IT for de-densifying and remote instruction.
  - a. UNO received its first "zoom bombing" a few weeks ago, which is causing IT to reexamine security. Zoom is initiating a mandatory update of security protocols in September, but UNO can put updates in place before that time if desired. As of now, the plan is to update UNO zoom protocols by August 17<sup>th</sup>, which will allow faculty to become familiar with security protocols prior to the semester beginning and hopefully avoid disruptions of classes during the semester.

- 3. Treasurer's Report: Senator Surface (May 2020) (Carried over from last month)
- IV. Standing Committee Reports
  - A. Committee on Academic and Curricular Affairs: Senator Wessling Academic and Curricular Affairs Committee did not meet in May 2020. No report. Summary of Work that will Continue Fall 2020:

- Our committee has tabled two items until the Fall 2020. We will continue to work on evaluating/revising current Academic Course Evaluation Tool and teacher evaluation process. Committee members have been working on this for two years. During this past year committee members meet a few times with Dr. Hank Robinson and identified eight issues that emerged around the current course evaluation instrument, as well as, potential recommendations. Faculty senate approved the formation of a task force to be formed by President Elliott Ostler to continue work in this area Fall 2020. Members of the Academic and Curricular Affairs Committee want to be kept up to date on task force progress and would like to still be involved in the discussions.
- 2. We will also continue to work on revising the Academic Integrity (Mandatory Reporting) Policy. The committee has also been working on this topic for two years. In order to have a more accurate statistics of students at UNO that have violated the Academic Integrity Policy, the committee feels "any" violation of the Academic Integrity Policy should be a mandatory report by faculty, regardless of consequence given to the student. As of now only violations that result in a consequence to gives a student an F in a course are required to be reported to the Office of Student Conduct and Community Standards (SCCS). Over the past year, the committee has corresponded a few times with Mr. Trent Fredericksen who is in support of our revision plan. At the end of this past year, 2019-2020, the committee made contact with Dr. Sarah Edwards at Mr. Fredericksen's suggestion to move forward in the policy revision process.
- B. Committee on Educational Resources & Services: Senator Surface
  - 1. Throughout the year, ERS focused on the development of a more accessible financial pathway using an online website to contribute to the Paul Beck Memorial Scholarship. The on the Faculty Senate website. Our first agenda item will be to ensure that the link is working correctly!
  - 2. Facilities and administrative cost policies and the need for a transparent reporting system at the college level concerning the requirements that research brings in these funds. The committee will continue to monitor budget reporting in the upcoming year.
- C. Committee on Faculty Personnel & Welfare: Senator Helm
  - 1. Ongoing Committee work: Following information received from several faculty concerning outcomes related to personnel complaints filed with Human Resources, the Behavioral Review Team and the Ombuds Service, the Committee is in the process of researching the related procedures and solutions.

  - The Committee on Goals and directions will continue to look into Solar Feasibility and possible resubmission of a Solar Energy grant to the Nebraska Environmental Trust
  - 2. With Collective Bargaining beginning in the fall, G&D will continue to work with the ad hoc committee on Faculty Advancement for a possible Non-tenure

track faculty promotion structure.

- 3. With a substantial number of UNO courses being taught by Adjunct Faculty, the committee will also look into possible support mechanisms and professional advancement for Adjunct Faculty.

- A. Ad hoc Committee on Faculty Advancement: Senator Ostler The Ad hoc Committee on Faculty Advancement stalled in the spring because of the immediate need to respond to online instruction and university operations. The primary focus of the committee is to develop a promotion and advancement system for non-tenure track faculty.

Further Discussion: Funds have been requested from the President's office to support the new office of Diversity, Equity, Access, and Inclusion. An Ad Hoc committee will continue to work on the Academic Integrity policy under the direction of Drew Neilson. The committee will also work on a UNO transportation and Sustainability committee and dissolve the current parking committee. The Ad Hoc committee assigned to work on new possibilities for non-tenure-track faculty will continue its work.
