AAC&U General Education Conference

The 2017 AAC&U General Education conference took place in late February. A key theme of the conference focused on the design of more meaningful assessment of student learning across diverse general education programs and courses. Important resources to aid in these efforts include AAC&U [VALUE \(Valid Assessment of Learning in Undergraduate Education\) rubrics](#). These rubrics can be used "as-is", or can be used as a starting point for creating your own rubrics to evaluate general education student learning outcomes.

General Education Assessment Deadlines and Information

Academic units at UNO that offer courses fulfilling [Social Science](#) and/or [Natural Science](#) general education requirements will be required to submit a general education assessment report for each of these courses no later than **April 21st, 2017**. There are many resources available to help you in this process including the [General Education Assessment Guide](#) and the [Gen Ed report template](#). Additionally, members of the Gen Ed Committee or I would be happy to meet you and your faculty to discuss the assessment process and expectations. General Education Assessment Mini-Grants

The [Assessment Mini-Grant Program](#) is being extended to 2017-2018. Co-sponsored by the Academic Assessment Committee and the General Education Committee, assessment mini-grants support assessment efforts on campus at the course and program level. This grant opportunity is particularly relevant for faculty teaching general education courses interested in learning more about assessment. Proposals can be for individual courses, GenEd courses, end-of-degree program assessment, or collaborative GenEd area assessments. **Proposals are due April 1st to Connie Schaffer, Faculty Fellow for Assessment, and can be for either Fall 2017 or Spring 2018.**
