2017-2018 PRIORITIES – ACADEMIC QUALITY, ASSESSMENT, AND STUDENT ENGAGEMENT

Since arriving at UNO in June of 2016, I have been extremely impressed with the level of commitment, passion, and professionalism displayed by all of the faculty and staff responsible for delivering general education and dual credit courses to our wonderful students. These are highly impactful programs and it is important that we collectively work to offer the highest quality courses that engage students and help them develop the intellectual foundations for success in their subsequent academic, personal, and professional endeavors. Your efforts undoubtedly will help to shape the future of Nebraska and our country. Accordingly, in 2017-2018, I encourage all of us to continue to focus on alignment of dual enrollment with on-campus courses, continuous improvement through our assessment efforts, and helping students more deeply engage with these important undergraduate courses.

1. Alignment

- a. Course alignment
 - i. It is important that dual enrollment and on-campus course offerings be aligned in terms of content, expectations, and rigor. Teachers, UNO faculty, and unit coordinators should work together to ensure dual courses maintain this level of alignment and are effectively meeting the needs of our students. All dual enrollment course syllabi should align with the minimum content requirements as reflected in UNO master syllabi for the course, should address any relevant general education outcomes as applicable, and should include the UNO course designation and title.
- b. Credentials
 - i. As you are aware, in 2016 the Higher Learning Commission (HLC) clarified their guidelines related to minimum faculty credentials required to teach dual enrollment courses. UNO's Dual program has been granted a 5-year extension to comply, and will use this time to support our existing dual enrollment teachers in obtaining additional graduate credits if necessary.

2. Assessment

- a. The General Education Assessment Committee has established a regular cycle of academic assessment for general education courses.
 - i. 2017-2018: General education courses in the [humanities and fine arts](#) distribution area.
 - ii. 2018-2019: General education courses in the [U.S.](#) and [global diversity](#) distribution areas.
- b. [The 2017-2018 General Education Assessment Guide](#) provides detailed expectations and instructions for completing your course assessment reports. Each academic unit at UNO with courses that meet humanities and fine arts requirements will need to submit assessment reports for these courses by **May 11, 2018** using the general education assessment [template](#).

3. Engagement

- a. General education is the foundation of UNO's undergraduate curriculum and constitutes the majority of courses offered through the Dual Enrollment program. However, students do not always engage fully in this part of the curriculum and may misunderstand its value and purpose. The General Education Committee developed the "[Value of Gen Ed](#)" proposition to serve as a resource for communicating to students the purpose and value of general education. Teachers are encouraged to address the value of general education with their students.

DID YOU KNOW?

1. The Office of General Education has established a site in the Canvas Learning Management System that includes discipline specific discussion boards and a wealth of information about dual enrollment expectations and processes to more effectively connect dual enrollment teachers, UNO faculty, and staff. All dual enrollment teachers and coordinators were sent an invitation to participate. Please contact our office if you did not receive an invitation, or have experienced technical difficulties.
2. UNO will be administering the Collegiate Learning Assessment (CLA+) to first-year students throughout the fall semester. THE CLA+ is a nationally normed assessment tool that measures the impact of UNO's curriculum in developing critical thinking, problem solving, analytical reasoning, and writing skills of our students.
