## WHY COMMUNITY ENGAGEMENT MATTERS TO MAVED

At the University of Nebraska at Omaha, community engagement is central to the university's **urban metropolitan mission** and its identity as an **engaged institution**. Within MavEd, it is a **powerful method** for delivering on the promise of general education and deepening student learning across multiple outcomes.

## Why It Matters for Students

- Builds Purpose: Students see their learning as meaningful beyond the classroom.
- Strengthens motivation, retention, and sense of belonging and responsibility
- Connects academic learning to career preparation and civic life
- Develops Transferable Skills: Communication, collaboration, adaptability, and ethical reasoning.
- Supports Equity: Engagement helps students connect with diverse perspectives and social contexts.

## **What Faculty Can Do**

Faculty are encouraged to incorporate community engagement by:

- Designing assignments in partnership with community organizations
- Framing enduring questions around social or civic issues
- Involving students in applied research, service learning, or advocacy projects

#### **Cultivates Transferable Skills**


Through real-world, applied projects with community partners, students develop essential skills that transfer directly to the workforce readiness.

- Critical thinking and information literacy
- Oral and written communication
- Collaboration and problem-solving



## **Advances Integrative Learning**

Engaging with community partners challenges students to synthesize course content with lived experience, interdisciplinary knowledge, social contexts, and authentic problems. It supports reflection, relevance, and real-world application—key aims of MavEd.



## Reinforces Civic Knowledge and Engagement

Community-based learning helps students connect course content to societal needs and democratic participation. Students explore their roles as citizens through direct interaction with community systems, organizations, and real-world issues.



# **Deepens Intercultural Awareness**

Working with diverse populations, organizations, and social systems helps students navigate complexity, recognize systemic inequities, and practice empathy — central goals of MavEd's intercultural learning outcome.



# **Creates Powerful Signature Assignments**

Community-engaged projects—such as working with a nonprofit, conducting applied research, or presenting to a public audience—can serve as ideal vehicles for these high-impact experiences. Projects involving community partners are sustained, real-world, reflective, and deeply relevant to students' lives and futures.
