## WELCOME TO UNO

### Pay the SEVIS fee

As soon as you receive a Form I-20 (F visa) or DS-2019 (J visa) from UNO, pay the SEVIS I-901 fee to the U.S. government online. Make sure you print a copy of this receipt. A receipt will also be mailed to you.

#### PAY SEVIS I-901 FEE

#### Obtain a Visa

As soon as you pay the SEVIS fee, schedule an appointment with the nearest U.S. Embassy or Consulate. You must complete the DS-160 visa application and pay the visa fee.

- Check with the U.S. Embassy or Consulate about specific requirements for obtaining your visa.
- F and J students must print their I-901 SEVIS Fee payment receipt and present it as proof of payment at their visa interview and when entering the United States at a U.S. port of entry.
- You may not use an email notice as proof of payment.

## Airport Pickup from Eppley Airfield Omaha (OMA)

UNO will only offer airport pickup to new students living on UNO's campus. Airport pickup is only available during designated dates and times and scheduling your pickup must be done online. Students will receive an email with information about scheduling an airport pickup.

#### NEW ILUNO Students Living on UNO's Campus

## IMMIGRATION FORMS AND PROCEDURES

## Customs

Remember the following:

- Be prepared to report if you are carrying any fruit, vegetables, food, money over \$10,000 or other items that are not allowed in the United States without special permission.
- We encourage students to research what items can be brought into the U.S.

After landing, be ready to present your passport, visa, and Form I-20 or DS-2019 to the immigration officer. They may ask for evidence of financial support, like a copy of your bank statement, and will ask questions about your plans in the United States. You will then go to a checkpoint where your bags may be inspected by a customs official.

## Form I-94, SEVIS, and Visas

U.S. Customs and Border Protection (CBP) will issue an electronic I-94. You will need to do the following upon entering the United States:

- Check your passport to make sure that the CBP officer has put an entry stamp indicating that you entered on a certain date, in a certain visa status (example: F-1), and can stay until a certain date or D/S (duration of status) in the case of F and J visa holders.
- Print out your I-94 form. You will need it for other purposes.

### IMPORTANT

- Be sure to hand carry your form I-20 or DS-2019 with your passport when you enter the U.S. Do not leave it in your luggage.
- Be sure to give your correct name (as it appears on the visa page of your passport) to the airlines when purchasing plane tickets.





### **Expenses to Get You Started in Omaha**

It is very important that you consider a financial plan for your immediate needs upon arrival in the United States. Prepare for the following expenses:

- ILUNO students should be prepared to pay tuition, fees, and health insurance during the first week of classes
- Travel emergencies
- Housing expenses and supplies
- Meals

## **Carrying Cash**

Carrying large amounts of cash is strongly discouraged. For most students and scholars, \$400 to \$500 in U.S. currency is enough to get settled in Omaha. With this amount, you should be able to cover initial expenses such as a night in a hotel, meals, and essential housing items like bedding and bathroom supplies. Whenever possible, it is recommended to pay larger expenses—such as housing deposits or the first month of rent—using a credit or debit card.

However, for ILUNO students, \$400 to \$500 may not be sufficient, as they must also be prepared to pay for tuition shortly after arrival. Additionally, because credit and debit cards are not commonly used or accessible in some countries, many international students arrive with cash and expect to pay major expenses this way. We advise students to plan accordingly and explore safer payment options in advance.

## **Credit and Debit Cards**

Credit and debit cards are the safest and most convenient way to spend money in the United States. Credit and debit cards are accepted almost everywhere. Students will open a US bank account during orientation but will only have access to their cards 1 to 2 weeks later. If you plan to use a credit card for expenses while in the United States:

- Prior to departure, confirm with your bank that your card(s) will work in the U.S.
- Make sure your account balance is high enough to cover all expenses





You can pay your student balance either in person on UNO's campus or online via MavLINK using any of the methods outlined below. For more detailed information, visit the UNO Cashiering and Student Accounts website.

- Credit or debit cards (Possible daily transaction limitations. Assessed a service fee charge of 4.25% on international credit/debit cards and 2.75% on U.S. credit/debit cards. Service fee charge is sometimes 0% for students with certain banks.)

## 圖 UNO HEALTH INSURANCE POLICY

All international students and scholars who are on an F or J visa are required to be enrolled in the UNO Health Insurance Policy. The charge will be added to your tuition and fees bill.

Students sponsored by their home country government with a financial guarantee on file at UNO that extends through the end of the semester will not be assessed insurance fees and do not need to request a waiver. Waivers will only be reviewed for students who have a U.S.-based employer plan.

### **Waiver Information**

Waivers are difficult to obtain. They are only available to students who are eligible and the non-UNO policy must contain the following:

- Must be a U.S.-based carrier that pays for care in Nebraska
- Deductible must be \$500 or less
- Unlimited major medical coverage including pre-existing conditions
- Unlimited medical evacuation and repatriation coverage
- Meets or exceeds Affordable Care Act requirements
- Coverage premium must be paid in full for the entire semester

## **Policy Review**

Each policy will be individually reviewed before a waiver is granted and must be submitted through the portal on MavLINK.

### **Students Under 19 Years of Age**

If you are younger than 19, the UNO Health Center requires authorization from a parent or guardian to provide health care. You have two options:

- **Recommended:** Have a parent or guardian complete the Power of Attorney Form (link below) and have it notarized. This form is only valid for 18-year-olds.
- If you are 17 and younger or are unable to complete a Power of Attorney form, a UNO Health Center staff member can call your parent or guardian at the time of treatment to obtain consent. Translation services are available. If your parent or guardian cannot be reached, we cannot provide treatment.

#### POWER OF ATTORNEY FORM (ENGLISH AND SPANISH)

#### **Proof of MMR (Measles, Mumps, Rubella)**

UNO requires all students, including international students and scholars, to provide immunization records in English from your doctor or hospital showing two Measles, Mumps, and Rubella (MMR) shots or a blood test report from a laboratory or doctor showing you are immune. A measles titer is a blood draw that measures the presence and amount of antibodies in the blood, which can indicate immunity to the disease. We recommend getting these immunizations in your home country. If needed, you can get the MMR vaccines or measles titer at the UNO Health Center in 102 Health and Kinesiology (H&K) on UNO's Dodge Campus. Appointments are required: 402.554.2374. There will be charges for your visit, which are covered under the UnitedHealthcare StudentResources plan.

If you do not bring these immunization records signed by your home country physician, you must have the first dose of the immunization immediately upon arrival. The second dose must be given 30 days later. You will not be allowed to continue taking classes if this requirement is not met. This policy includes all UNO students, intensive English students in the ILUNO program and IPD students.





### **Tuberculosis Screening**

In addition, UNO requires all international students and scholars to complete a tuberculosis test at the UNO Health Center upon arrival. Appointments are required. Call 402.554.2374 to schedule. There will be charges for your visit, which are covered under the UnitedHealthcare StudentResources plan.

## **Meningococcal Meningitis Disease**

Nebraska State Law requires students and scholars living on-campus read this information on Meningococcal Meningitis Disease and Immunization (Menactra/MCV4 or Menomune/MPSV4). Parents of students younger than 19 are also required to read this information. UNO encourages all students and scholars to consider getting this vaccination and to become knowledgeable about meningitis and its symptoms. The vaccine is available at the UNO Health Center.

Meningococcal Meningitis Disease is a severe bacterial infection of the bloodstream and meninges (a thick lining covering the brain and spinal cord). It is a relatively rare disease and usually occurs as an isolated event. Clusters of cases or outbreaks are possible. The meningococcus germ is spread by direct close contact with nose or throat discharges of infected people. College students who live on campus have a slightly higher risk of getting this infection than others their age.

Students and scholars who do not want the vaccine must first read the information on the website. Signing the immunization waiver indicates that you understand the possible risk of not receiving this vaccine. If you are under 19, a parent must sign the waiver for you.

#### ILUNO Intensive English Students, Undergraduate Students, Graduate Students, and Scholars

All new international students, including those transferring from another U.S. school and those moving from ILUNO to UNO, must participate in International Student Orientation. Orientation and academic advising for incoming students may take place both online and in person. More information will follow as it becomes available.

How to Register for International Orientation

- **1.** In MavLINK, click on the "Undergrad Orientation Signup" link (select this link regardless of undergraduate or graduate status). This can be found on the left-hand side of the home page in the Admissions drop-down menu. The orientation registration form will pop up in a separate window.
- 2. Review your personal information before completing the form.
- 3. Follow the instructions for international orientation registration.

## Pick Up Your MavCARD
