Federal Grant Programs

DHS Targeted Violence and Terrorism Prevention Grant Program (TVTP)

• The TVTP Grant Program is meant to help prevent targeted violence and terrorism by creating partnerships between the government, the private sector, and local communities. They fund local, state, and tribal governments; nonprofits; and higher education institutions.

FEMA Nonprofit Security Grant Program

• The mission of the Grant Programs Directorate is to enhance security for at-risk nonprofit organizations. It seeks to bring together government and private organizations to increase security and preparedness for at-risk nonprofit organizations.
