- 2006. The Equity Scorecard Project. The Equity Scorecard Project is modeled on the Diversity Scorecard work at the University of Southern California's Center for Urban Education. Its goal is to increase the rate of access, retention and graduation for historically under-represented students, with attention to first generation college students and inequities based on race and ethnicity.
