
Staff Advisory Council Mission & Purpose

By-law Proposed Changes


- 2023-2024 Council Year Review
 - The PD fund will be permanently funded.
 - The SAC Director of Finance will partner more closely with the PD committee chair to ensure more seamless distribution of funds.
 - New SAC members will attend an Orientation session.
 - The "Strategic Planning and Culture" committee will now be called "Strategic Planning", as each other committee impacts culture across campus.
 - The SAC culture survey will return to being distributed every two years (back to pre-pandemic expectations).

Community Engagement Committee

- We support, promote, and offer volunteer opportunities for staff to participate in.
- We promote a well-rounded approach to wellness by utilizing the UNO 8 Dimensions of Wellness in our planning.



Events Committee

- Plan and execute 2 annual events; Fall Picnic and Spring Pancake Man
 - Logistics, communication plan, and day-of
 - Outreach for departments that are unable to leave positions during events
- Meetings are monthly to stay on track for campus event planning procedures

Diversity, Equity, Access & Inclusion Committee

- We work to streamline diversity, equity, access and inclusion efforts across all UNO staff and SAC standing committees.
- We ensure that SAC follows the definitions of the University DEAI council.
- We focus on representation, advocacy, educating and equitable access at UNO.
- We make recommendations as needed to UNO SAC, UNO Human Resources, DEAI office, and other relevant departments.
- We make recommendations as needed to SAC committees to ensure DEAI standards are being upheld.
- We collaborate with committees and relevant UNO departments as needed on important initiatives (for example: SAC survey, work culture, professional development opportunities, events, etc.)
- We submit an annual report to the SAC President, SAC committees, and publish on SAC website. Our report provides accomplishments, areas of opportunities, and recommendations.





Professional Development Committee

- The Professional Development Fund supports professional development opportunities for staff not otherwise available through other programs or departmental funds.
- Committee meets monthly to review applications and select opportunities to fund for UNO staff members.
 - Applications are reviewed individually prior to monthly meetings and selected by a majority vote.

 - Student Fees for Staff
- Champion a comprehensive plan to present to stakeholders on campus regarding findings
