

Policy and Procedures for Smudging in On-Campus Student Housing

I. PURPOSE

The University of Nebraska (hereafter referred to as "UNO" or "the University") does not discriminate based on race, color, ethnicity, national origin, sex, pregnancy, sexual orientation, gender identity, religion, disability, age, genetic information, veteran status, marital status, and/or political affiliation in its programs, activities, or employment.

Many Native Americans (Native American/American Indian/Alaskan Native/Native/Indigenous/First Nations are all interchangeable terms referencing the peoples indigenous to North America and may be used throughout this document) are practitioners of tradition and prayer involving the use of sacred plant medicines. The University recognizes sage, cedar, sweet grass, tobacco and other Indigenous plants as traditional Native American medicines and essential elements of tradition, prayer, and spiritual healing. The University is committed to providing a pathway for Indigenous students living on-campus who wish to smudge.

The University of Nebraska at Omaha is located on the ancestral homeland of Native Americans, and the University recognizes the deep connection that Native people have to the land. UNO is committed to supporting Native students by facilitating the continuation of and rights to their spiritual practices, as acknowledged and protected within the American Indian Religious Freedom Act of 1978.

The University is a <u>smoke-free campus</u> and the <u>Housing and Residence Life (HRL) Community</u> <u>Policies</u> prohibit the use of candles and incense within University housing

This procedure outlines the process Indigenous students may be granted a reasonable exemption to those policies to smudge in on-campus residential facilities.

II. SCOPE

This procedure applies to:

- a. Indigenous students
- b. who live on-campus, and
- c. who request to smudge in accordance with Indigenous tradition and prayer within residential spaces operated by or affiliated with UNO.

This procedure applies to smudging requests and exemptions that are mutually agreed upon by the student and University staff.

III. DEFINITIONS

This procedure will rely on the following definitions:


- a. Smudging The practice of cleansing or purifying oneself, space, or objects through producing sacred smoke by burning a small amount of sacred or medicinal plant medicines. This tradition is common and vital to many Indigenous peoples throughout North America.
- b. Sacred Plants Medicinal herbs, plants, and/or grasses that are burned, ingested, carried, or used during ceremony and prayer. These may vary between practices and traditions, but commonly include sage, sweet grass, and cedar. The University will not permit the use of any herbs, grasses, or plant materials which violate local, state, or federal laws.

IV. PROCEDURE

Housing and Residence Life will adhere to the following procedure when supporting students who wish to smudge within their living spaces in on-campus housing:

- The student shall first make their desire known by submitting a Smudging Exemption Form
 to Housing and Residence Life (HRL) and the Intertribal Student Council (ISC) Advisor. This
 can be submitted in-person via paper form or by completing the <u>electronic exemption</u>
 request form.
- 2. Following receipt of the Smudging Exemption Form, and Associate Director (AD) of HRL and the ISC Advisor will:
 - a. Work in partnership with the Associate Director for Housing and Residential Life to determine approval of the request. The student may be asked to meet with HRL staff, the ISC Advisor, and other university staff members necessary as a part of the approval process.
 - b. As a part of the review and approval process, the AD will contact the students' roommates to discuss concerns (allergies, etc.) about smudging in the residential space.
 - i. If no concerns exist, the exemption approval process will move forward.
 - ii. If concerns are raised, the AD will work to help mediate or resolve those concerns before the exemption approval process continues.
 - c. As part of the approval process, the student requesting the exemption may be asked to:
 - i. Review fire safety information related to housing and university policy.
 - ii. Attest that they have a fire-proof container in which to burn their smudging materials.
 - iii. Attest they will not dispose of any burnt materials in trash receptacles within their apartment or residence hall building.
 - iv. Attest they have reviewed the floor plan of their building and are aware of the locations of the exits, fire alarm pull station, and fire extinguisher closest to their apartment.
- 3. After receiving an approved exemption, the student will smudge according to the following expectations:
 - a. The student will provide all the materials needed. This includes the sacred medicines, a lighter (matches are not allowed), and a sufficiently large, non-

- combustible fire-proof (shell, metal, ceramic, etc.) container in which they will burn the sacred medicines.
- b. The student will smudge within their own residential space, including their individual room and any shared living areas within the residential space which the student and their roommates have mutually agreed upon.
- c. The student will place the sacred medicines in the fire-proof container and ignite them. The sacred medicines must stay within or upon the container throughout the smudging.
- d. Following the smudging, the student will be responsible for extinguishing and disposing of the burnt remains of the sacred medicines in a manner that is consistent both with their spiritual traditions and with UNO fire safety policy/expectations. The burnt material may not be disposed of in any trash receptacles within their apartment or residential building.
